Richard E. Dauch is trustee and beneficiary of the Richard E. Dauch Annuity Trust DTD 4-30-06, and is trustee of the Richard E. Dauch Annuity Trust 2010 No. 2, U/A DTD 9-1-07, which together own a total of 468,413 shares as of 12/31/07. Richard E. Dauch is co-trustee and beneficiary of the Dauch Care Trust, which owns 433,700 shares as of 12/31/07. Mr. Dauch beneficially owns 180,000 shares of restricted stock that will vest no earlier than December 31, 2009. Mr. Dauch holds options exercisable within 60 days of 12/31/07 to acquire 1,554,500 shares. Mr. Dauch is president of the Richard E. and Sandra J. Dauch Family Foundation, a charitable foundation under Internal Revenue Code Section 501(c)(3), which owns 411,710 shares as of 12/31/07.

Richard E. Dauch disclaims beneficial ownership of all 6,260,702 shares held by the Sandra J. Dauch Gift Trust dated May 25, 1998, of which his spouse is trustee and beneficiary. These shares are excluded from the amount shown in Item 9 of the Cover Page.
